RESOLUTION 2 - 2018

A RESOLUTION AUTHORIZING THE EXECUTION OF A CONTRACT FOR PARTICIPATION IN A REGIONAL COUNCIL OF GOVERNMENTS FOR THE PURPOSE OF JOINING RITA (REGIONAL INCOME TAX AGENCY)

WHEREAS, the City of North College Hill intends to join the Regional Council Of Governments in order to benefit from the Regional Income Tax Collection Agency; and

WHEREAS, The Regional Income Tax Collection Agency will assist the City Of North College Hill with a centralized method of tax collections; and

WHEREAS, the City of North College Hill will hold two public hearings to seek input and share information to residents;

WHEREAS, the City of North College Hill desires to enter into said contract to maximize and improve the overall tax collection process.

NOW, THEREFORE, be it resolved by the City of North College Hill as Follows:

SECTION I

The Council of the City of North College Hill hereby directs the City Administrator and Finance Director to take the necessary steps to execute the contract template attached hereto as Exhibit upon satisfaction of all conditions precedent to contract execution.
